Dear Faculty,

[A friend sent me a screenshot of a comic that speaks to the way our K-12 educational system subverts creativity in favor of “right” answers, the effects of which many of you see in your classrooms.](#) Fair Use guidelines don’t cover use of material outside of the classroom, and I don’t want to pay \$35 for a license, so you’ll have to visit the website to view the comic.

FAQ’s about captioning faculty-created video

We’ve received a number of questions related to captioning videos.

1. Why is captioning required?

Section 504 of the Rehabilitation Act of 1973 and Title II of the ADA require that institutions receiving federal monies make web-based content accessible to students and the public, respectively. All this jargon can make one’s eyes glaze over. Suffice to say that all student-facing video is supposed to be captioned with 99% accuracy, which is why you probably received an email from your dean asking you to caption videos.

2. None of my students have declared that they have a disability and need accommodations, so why should I create captions for my videos?

Set aside, for a moment, the federal requirement for accurate captions. There are other, more compelling reasons to create captions for the videos you have created. First, *accessibility* issues go beyond accommodations. [A helpful framework to consider is Universal Design for Learning](#), which encourages educators and educational institutions to design learning experiences and spaces in ways that include everyone. For example, providing video captioning helps students whose first language is not English understand the audio in a video. Captions make video accessible to students who are working in a noisy environment. Captions also help people whose hearing is compromised – perhaps someone who wears hearing aids – and can better understand the audio when captions are enabled. Bonus – When video is captioned in YuJa, a transcript is created, as well.

3. What should I do if I link to a video on YouTube that isn’t already captioned?

Continue to link to the YouTube video. Do not add captions to a video you *did not create* if they do not already exist. If you have video on YouTube, you can link to it from YuJa. You do not need to download the YouTube file or recreate it.

4. Do I have to have captioning enabled when I show a video in class?

No, but if the option is available to you, consider using it, especially if you have students who struggle to understand spoken English.

5. Are the auto-generated captions in YuJa accurate?

YuJa reports that captions will be 80% accurate (videos filled with medical terminology may be less accurate). In order to make the captions 99% accurate, faculty will have to edit and/or replace poorly written captions with more accurate ones.


