We use the co-teaching model for clinical teaching. Students, University Supervisors and Cooperating Teachers/Mentors are trained to use the co-teaching model and the T-TESS model for new teacher evaluation. Teacher candidates work with their cooperating teacher to plan lessons and activities, develop and administer assessments, teach and participate in all aspects of teaching. We feel this model provides a wide range of experiences that will be beneficial as the candidates begins their first year teaching.

Texas Wesleyan University's School of Education provides degree programs leading to teacher certification in Core Subjects EC-6 with ESL certification, Core Subjects EC-6 Bilingual, Secondary (English, History, Mathematics, Life Science) and All Level (Music, Spanish, Physical Education). We are currently pursuing TEA approval to add 7-12 Social Studies certification. In March 2022, we received a Noye Capacity Building grant. As part of this grant, we will reactivate our 4-8 Math and 4-8 Science certification tracks, revising our 7-12 Life Science track to allow for Composite Science certification, in addition to adding an 8-12 Computer Science certification track. We have offered elementary Bilingual certification since 1968. Approximately 20 to 30 EC-6 Bilingual teachers were certified each year until 2013. That number was greatly reduced due to the expiration of a grant for Bilingual certification. In 2017, we were awarded a Department of Education grant to provide scholarship assistance to the bilingual program students. This grant also provides professional development for teachers and parent academies for parents of children in low income, high minority population schools. This grant will continue the 2021-2022 school year. We offer a 5th-year option that provides our undergraduate teacher candidates the opportunity to obtain a Master's degree. Most students in the teacher certification programs are first-generation college students who transfer from area community colleges such as Tarrant County (TCCD), Dallas (DCCD), Hill, and Weatherford Community Colleges. We launched our Texas Wesleyan Teacher Residency program in fall 2020. At the graduate level, Texas Wesleyan University offers programs leading to certification in School Administration, Reading and Writing, Reading Specialist and School Counseling.
